- e. F & V Sewer plant report – James Green – James gave the council an update on the sewer plant – Discussion

8. New Business

- a. Budget items need to be turned into the office for the finance officer for 2020 – 2021 budget.
- b. Tires for the backhoe need to be ordered – approx. \$700 per tire – price came in at \$2910 installed. Motion by Marcero to purchase the tires from Waddles (Pomp Tires) for a cost not to exceed \$3000.00, supported by Klavon – Voice vote, all in favor motion passed.
- c. Lights for Ash Park, possible loan from the Village to Ash Park for the lights, possible increase budget to the park, used to be \$30,000.00 before. Tabled
- d. Meeting Schedule – President Buckingham presented to council the proposed meeting dates for 2020. Motion by Reiser to approve the meeting dates, supported by Marcero – Voice vote, all in favor, motion passed

- a. President Buckingham – Thanked Amee, Keith, Jon, and Rob for setting up the Christmas party at the Village hall. He also thanked all who attended.
- b. President Buckingham – Part-time worker Rob Pane – Discussion
- c. President Buckingham – Carleton Collision – Not getting anywhere, what is council decision, have stated in the past if no movement to seek prosecution. Donovan stated that we need to go forward on the prosecution, council agreed. Buckingham to contact the Village attorney.
- d. Marcero – Wanted to thank the guys for the great job everyone did for the Santa parade.
- e. McCormick – Has been checking on the work the Police clerk does, wages much lower than other clerks' job – feels need to raise her wages. Advised that we would have to wait for contract negotiations to increase the wages.
- f. McCormick thanked everyone for consideration for the park lights.
- g. President Buckingham wished everyone a Merry Christmas
