3. Minutes

Motion was made by McCormick to accept the minutes of the regular meeting dated May 1,2017. Motion supported by Goodnight. All in favor, motion carried.

5. Council Actions

a. Rezone of Monroe Ave. east of Beaver St. – Dave Jones -- Planning commission met on 5-15-2017 and it is their recommendation to rezone Monroe Ave. from Beaver Street east on the South side of Monroe Ave. to the car wash, and on the North side of Monroe Ave. to the oil change to residential. Motion by Goodnight to follow the Planning Commission recommendation and rezone to residential, supported by McCormick. Discussion – Yoas brought up that he felt the North side should be rezoned to residential but that the South side should stay commercial as the rest of the block to the south is still commercial and this would give the opportunity to expand the businesses. McCormick brought up that people are having a problem getting loans with the houses being in a commercial district, (could not rebuild without approval of the council). Collert brought up he felt the present council could give a variance to the property owners stating they could rebuild – Osment



stated the present council could not bind a future council. Reiser stated he felt changing the zoning on either side is a mistake, could be a small business could move into a home such as a real estate office. Roll call vote
