Instructions for Completing Application:

General: Mechanical work shall not be started until the application for permit has been filed with Village of Carleton. All installations shall be in conformance with the Michigan Mechanical Code. **No work shall be concealed until it has been inspected.** When ready for inspection, call Carleton providing as much advance notice as possible. Must provide the permit number and/or address for the inspection. If the inspection is not compliant and/or fails, additional fees may be required. **Re-inspections fees are \$50.00.**

There will be a DOUBLE PERMIT FEE assessed for all requested inspections prior to obtaining appropriate permits, and /or work done without the benefit of required permits.

Expiration of Permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within 180 days after issuance of the permit or if the authorized work is suspended or abandoned for a period of 180 days after the time of commencing the work. A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN 180 DAYS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED. THE CHARGE TO REOPEN A CLOSED PERMIT IS \$50.00
