VILLAGE OF CARLETON ORDINANCE NO. 192

MONTHLY SERVICE FEE FOR VILLAGE
SANITARY SEWER SERVICE
FOR PROPERTIES LOCATED OUTSIDE OF THE
VILLAGE OF CARLETON, MICHIGAN

An Ordinance to establish a monthly service fee for village sanitary sewer service for properties located outside of the Village of Carleton, Monroe County, Michigan.

The Village of Carleton ordains:

Section 1: Monthly Service Fee for Village Sanitary Sewer Service for Properties Located Outside of the Village

A schedule of the monthly service fee for village sanitary sewer service for properties located outside of the Village of Carleton is hereby established. These service fees are payable monthly to the Village of Carleton. Those monthly service fees are as follows:

Section 2: Severability

The various parts, portions, sections, and clauses of this Ordinance are hereby declared to be severable. If, any part, portion, sentence, paragraph, section, phrase or clause is adjudged unconstitutional or invalid by a Court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.

Section 3: Repeals

All Ordinances or parts of Ordinances, in conflict with this Ordinance are, to the extent of such conflict, repealed.

Section 4: Publication

This ordinance shall be effective after legal publication and in accordance with provisions of the Act governing same.

This ordinance duly adopted on August 10, 2015, at a regular meeting of the Village of Carleton and will become effective August 25, 2015.
