3. Jones – Asked if the January meeting will be in person. As of right now, yes, it will be in person – Osment has been checking with the legislators and there is a bill pending but nothing has been passed yet
4. Lenora Buckingham – Thanked everyone for their patience with her taking the minutes (surgery).
